Building-wide staffing and scheduling decisions will be made based on the quantity of students who are projected to participate in this Programme, so your commitment to entering it is critical.

IBDP Exam Registration Agreement

As an International Baccalaureate Diploma Programme (IBDP) Candidate, I acknowledge that it is mandatory for my child to be registered for six IB Exams and for Creativity, Activity and Service (CAS), the Extended Essay and Theory of Knowledge by the IBDP Coordinator, Mrs. Flynn, by the September, 2025 deadline. I also acknowledge and agree to pay \$714 towards the cost of my IB registration with a check made payable to SHS CAS Club or with cash by September, 2025. I understand that Mrs. Flynn will work with families on an individual basis should a financial need be present. The district also waives testing fees for qualifying students who fill out and submit the Stamford Household Income Form and are approved.

Please be aware that if your child does not sit for one or more exams or if your child is denied an IB course grade (and thus the IB Diploma) due to a violation of the SHS IB Academic Honesty Policy, I may be asked to reimburse the Stamford Public School district for ALL dues paid to the International Baccalaureate Organization associated with course registration(s) and other IB Diploma Programme Registration fees. The International Baccalaureate Organization considers all registrations final and therefore provides no refunds to schools. For this reason, Stamford High School provides no refunds to students.

The International Baccalaureate Organization charges a late fee of \$38 for registration of any subject beyond the published registration deadline (November 1, 2025). Registrations or amendments after the late registration period are charged \$150. No student will be registered without payment.
